Mastermind Discussion

Cost of Attendance (COA) for AY26-27 Review

- The COA is built annually to reflect the cost of attendance in the next academic year and to allow the Financial Aid office to award loan packages to the students.
- The budgets reflect information from the LivingWage Calculator for Lewis & Clark County in Montana.
 - There are three sets of numbers that Valerie uses for comparison. The College Board, National calculations and the LivingWage Calculator for Lewis & Clark County in Montana.
 - Last year, the College Board calculations for Denver were used.
- Books and supplies are averaged across the programs = \$1372. This was calculated for AY2526 and is calculated every other year.
 - Books and supplies also includes \$500 to allow for the purchase of a computer. (HC requirement)
 - Computer cost increased \$50 due to new requirements for software and systems.
 - Internet costs are built into books and supplies also. \$35/month.
- Parent plus loans will be limited in the future.
- The instate students who live with their parents have a lower COA because transportation is reduced by 25% and the food costs are reduced by 50%.
- There are increases in the out of state calculation and WUE increased the most.
- The Montana Board of Regents set the FY27 instate residential tuition and mandatory fee rate at \$2,359.95 for 12 credits. (OCHE is pushing for students to enroll in 15 credits per semester)

Action: Todd Dumas made the motion at accept the 252627 COA as presented to the Budget Council on January 26, 2026. Larry Taylor seconded the motion. Approved unanimously.
