Information Items from Facilities & Plant:

- -Long Range Building Plan: November 17th a meeting will be held in room 002/003 on the Donaldson campus
 - -Russ reviewed information that will be discussed at the meeting
 - -The group discussed the long range building plans
- -Brandi discussed that the more we can tie long range building plans to a process the more we can tie it into Accreditation
 - -Cliff Funding Report was reviewed
 - -Russ reviewed that we should be receiving more funds than we are currently receiving
 - -We have to ensure that we continue to have students
 - -This is everyone's responsibility
 - -Furloughs are a real possibility on larger campuses in MT
 - -We would have to maintain an 800 FTE to not have a shortfall
 - -Our tuition will stay the same next year and the larger institutions will increase 3%

- -Valerie Osborne is on-board and currently working with Deb Hansmann for training purposes in anticipation of Deb's retirement at the end of December
 - -Russ reviewed the card key entry test that will occur over the summer 2010

Learning Outcomes Assessment:

- -Brandi reviewed current information
- -The first step has been completed and is now at the point of assessment
- -Important that non-academic components assess outcomes also
- -How can we as an institution really improve and show that we are doing what we say we are -How do we as a committee start that dialogue?
 - -Funding surveys and tests for the non-academic components
 - -What is the best way to assess learning outcomes?
- -Validates what we are doing
- -We are very poor at demonstrating what we are doing but the Accreditation process is helping us improve
 - -Outcomes determine what is working and would help during the funding process
 - -The group discussed examples of how to assess learning outcomes
- -Jennifer suggested that assessing first semester students and then assessing them again 2 years late is a good idea

ACTION ITEM: Best practices and areas that have the data have gone about assessing ACTION ITEM: Make a budgetary commitment to fund institution-wide learning outcomes assessment testing as a pilot project in various areas; exit testing
